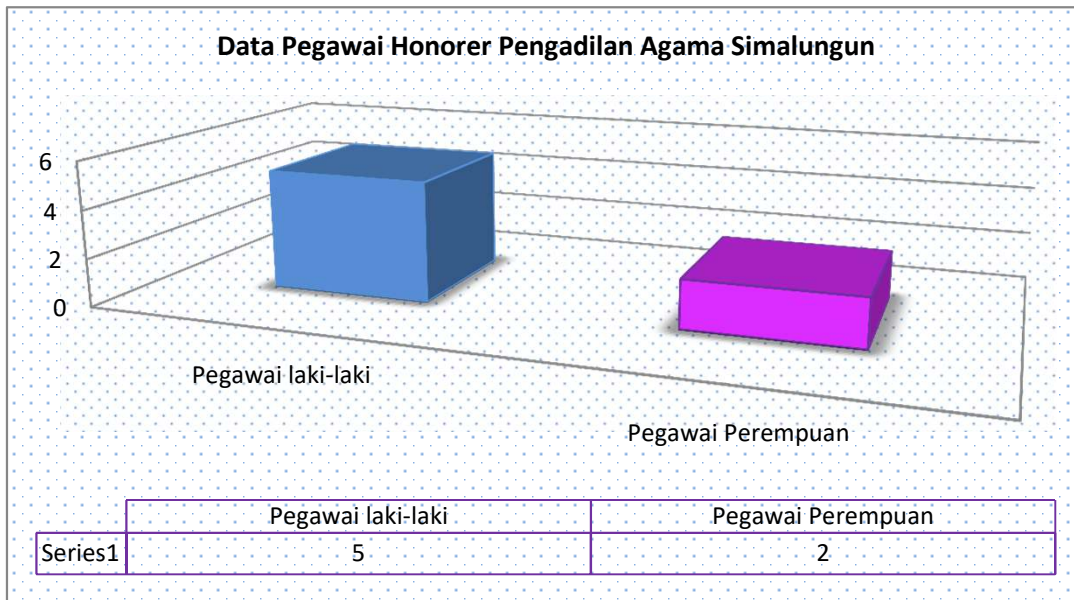

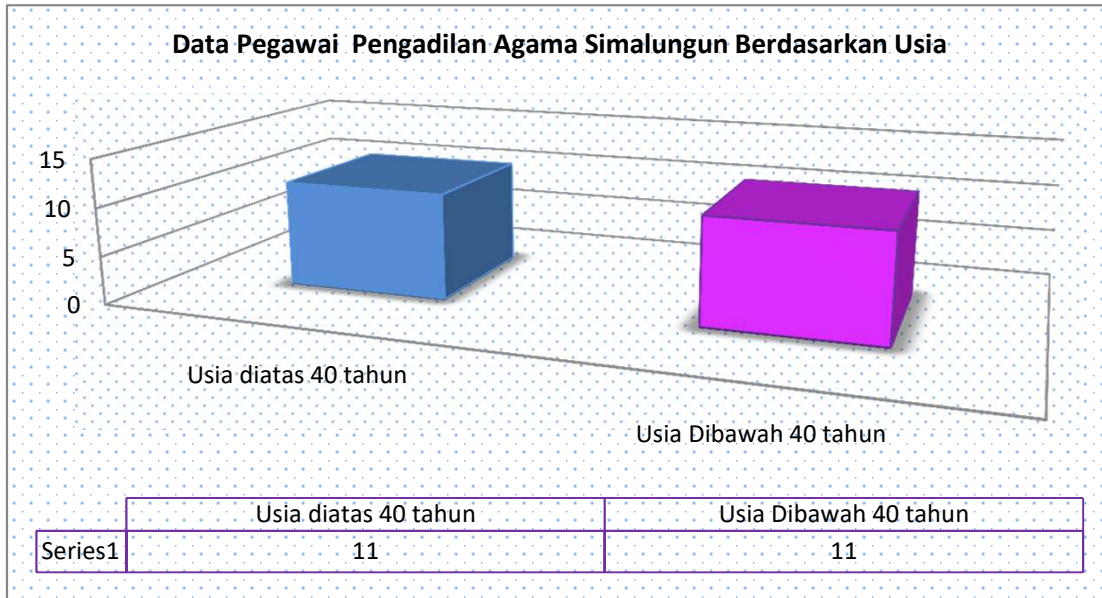

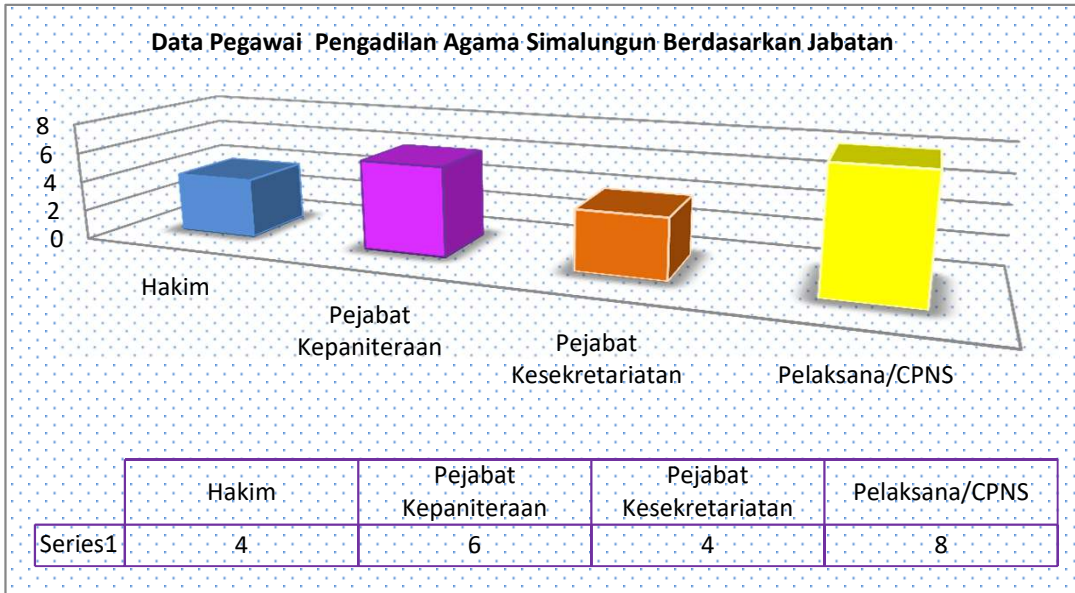
### Data Pegawai Pengadilan Agama Simalungun Berdasarkan Usia

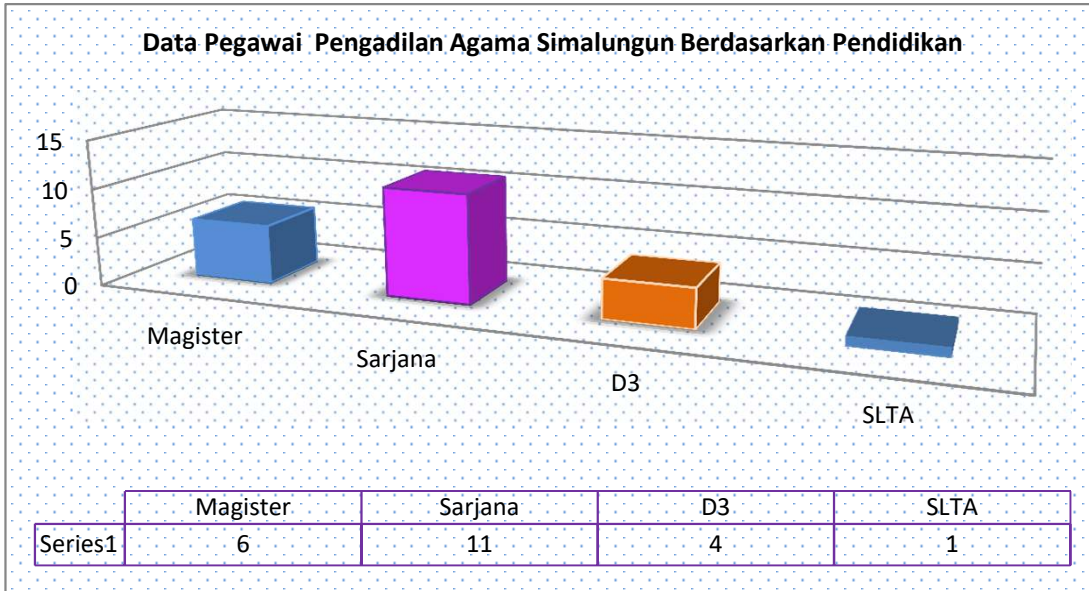
